- a. The firms / agencies may send Quotation as Individual, Firm/s or Consortia, giving out the details of the partnership model.
- b. Must have a Permanent Account Number (PAN) from Income Tax authorities.
- c. All the communication to IISSSC including the Quotation shall be signed by the authorized representative of the Firm / Agency / Consortia on letter head
- d. Information which is considered proprietary, should be clearly marked "proprietary" next to the relevant part of the text and it will then be treated as such accordingly.
